ArtsWave Annual Meeting Celebrates Achievements, Honors Leaders and Charts Future Course for Arts in Greater Cincinnati

CINCINNATI (October 30, 2024) – ArtsWave, the engine for the arts in the Greater Cincinnati and Northern Kentucky region, held its Annual Meeting yesterday at The 21C Museum Hotel, marking a year of significant accomplishments and setting the stage for future initiatives.

Life Trustee Honor

In recognition of his decades-long commitment to the arts, a special motion was put forward to elect Jack Rouse as an ArtsWave Life Trustee. Rouse's contributions span multiple cultural institutions since his arrival in Cincinnati to found CCM's Musical Theatre program in 1969, including pivotal roles at Kings Island, The Port, 3CDC, and the Cincinnati Pops Orchestra. He's previously served multiple terms on ArtsWave's board since 2010 and was an integral part of ArtsWave transition from the Fine Arts Fund.

Sachs Fund Prize Recipients

The 2024 Rosa F. and Samuel B. Sachs Fund Prize, a bequest from the late Samuel B. Sachs to honor outstanding artistic accomplishments and contributions to the cultural life of the Cincinnati Region, was awarded to two outstanding leaders in the arts community:

- 1. Kim Kern, President & CEO of The Children's Theatre of Cincinnati (TCT)
- 2. Toilynn O'Neal Turner, CEO and Founder of the Robert O'Neal Multicultural Arts Center (ROMAC)

ArtsWave President & CEO Alecia Kintner commented, "Recognizing these innovative leaders for the impact they've made on our region is one of ArtsWave's greatest joys.

Kim's vision of a restored Emery Theater in OTR, the original 'home' of TCT, will have an impact on our urban core for years to come. Toilynn's efforts to fill a gap in services for emerging artists in the West End is adding to a broader vision of a thriving, inclusive West End neighborhood. We thank them both for their many contributions that have brought distinction to our region."

Initiative Updates

The meeting provided updates on several key ArtsWave initiatives:

- 1. "More Arts, More Kids": a challenge to raise \$1+ million for 50,000 arts field trips for area 1st through 6th graders. The pilot year saw great success and year two aims to build on that and send an additional 15,000 students on field trips.
- 2. Creative Placemaking Partnership: The new collaboration with meetNKY was introduced, and an update given on the first project to come from the partnership, the Kentucky Gateway mural by internationally renowned artist Maya Hayuk.
- 3. ArtsWave App Launch: The new app, powered by the region's largest event calendar, Cincy A&E, has seen over 7,000 downloads since its October 1 debut and will be instrumental in ArtsWave's path forward.

This year, ArtsWave raised a record \$12.5 million through its yearly campaign from individuals, businesses and foundations to further the region's strategic growth goals.
